RSL Australia President Greg Melick said the passing of Her Majesty will be felt by all veterans who particularly valued her association and patronage of the League for more than 70 years.

"Her Majesty Queen Elizabeth has been an outstanding servant and leader of the Commonwealth for the duration of her reign and the RSL was honoured to have her as our Patron," Greg Melick said.

"Her passing makes this a period of great sadness, but also is a time to reflect on her unstinting service and contribution to Australia, Great Britain and all the nations of the Commonwealth.

"We recently marked Her Majesty's Platinum Jubilee, with RSL Branches and Sub-Branches throughout Australia illuminated in purple to mark her extraordinary 70 years on the throne. Such was the esteem in which she was held by our organisation and its members."

Greg Melick said Her Majesty Queen Elizabeth II was a unique monarch and an outstanding Patron. Of the RSL

#### **Save the Dates**

Following consultation with the Executive of Woden Valley RSL Sub-Branch it is the intention to temporarily suspend the meeting of the Eddison Day Club for the remainder of the year. This is due to the low numbers that are attending each Friday for lunch.

We have applied for a grant from DVA to hold three seminars in early October for Veterans' Health Week, whose theme this year is "Eat Well". These lunches will include a short talk by a dietician on healthy eating and then an individually packed lunch prepared by a local veteran couple who will cater and serve to each attendee.

We have also received another grant to pay for some bus trips out of Canberra. We had three in November 2020 which were well patronised. We have done some research on <u>four</u> bus trips to be held in October and November this year.

At present we are considering the following tours:

- a tour to the Southern Highlands stopping at Berrima, Moss Vale (where we will have lunch at the Moss Vale Services Club), visit Robertson and return to Holder by 4.00 pm;
- a tour to Yass and District, visiting Cooma Cottage, visit Harden with lunch at the Harden Country Club, visit the local sculptures including 'Bill the Bastard', maybe St Clements Monastery, and return to Holder by 4.00pm;
- a tour of Bungendore for morning tea, Braidwood shops with lunch at the 'Loaded Dog' at Tarago on the other side of Lake George, returning to Bungendore for a visit to the Woodcraft Shop, Leather Shop, the Antique Shop or a coffee. Then returning to Holder by 4.00pm;
- a tour to Cooma. We have a Sub-Branch member who will do a running commentary during the trip, as he knows the area well. We will have lunch at the Cooma Ex-Services Club and visit the area where a founding member of the Woden Valley RSL Sub-Ranch.

All tours will leave from the bus-stop outside the Woden Valley RSL Sub-Branch at 27 Mulley Street at 9.00am. Bottled water will be available for each tour. Face masks will also be available.

The grant will not cover all four, so we will have to conduct the ones that receive the most response. We will be using Deanes Coaches as we did last time. They have a 57 seat as well as a 62 seat coach. This will allow safe social distancing. We will endeavour to have Mr Reece Campbell be our coach captain once again.

We would appreciate people contacting the Sub-Branch to express their interest to patronising both the Veterans' Health Week functions and the bus trips they would prefer.

#### Vale Dr Allan Hawke AC

Staff of the Department of Veterans' Affairs and the veteran community pay tribute to the life of Dr Allan Hawke AC who passed away this week at the age of 74.

Dr Hawke dedicated his professional life to serving the Australian public, including his tenure as the Secretary of DVA from 1994 to 1996, and in this time made an invaluable contribution to Australia's veteran community.

Current DVA Secretary Liz Cosson AM CSC said Dr Hawke's legacy includes introducing and delivering significant policies that continue to benefit Australia's veterans and families today.

'Dr Hawke's contribution cannot be overstated. He oversaw the introduction of the Compensation Claims Processing System, new veteran treatment cards, and the establishment of the Repatriation Medical Authority,' Ms Cosson said.

'His work to introduce Statements of Principles to establish a causal connection between service and medical conditions remains key to our veteran support system today.

'Allan also oversaw the dignified and respectful commemoration of the 50<sup>th</sup> anniversary of the end of the Second World War, honouring the amazing generation of Australians who served to protect our nation in that terrible conflict. Many who were in school at this time will remember the strong focus of Australia Remembers on engaging children. The legacy of this can been seen in the number of schools marching and remembering each Anzac Day.

'He was highly regarded and respected by DVA staff, and is remembered as a leader who invested in people and fostered a strong culture, inspiring his staff to serve and leading by example.'

In recognition of his life and public service, Dr Hawke was made a Companion of the Order of Australia in 2010.

We honour his service and his legacy.

#### - A TAXING ISSUE -

## ROYAL COMMISSION RECOMMENDS HARMONISING LEGISLATION - PROPOSED LEGISLATION ENTRENCHES DISHARMONY -

The Interim Report from the Royal Commission into Defence and Veteran Suicide recommends "that the Australian Government should, without delay, implement legislative reforms to simplify and harmonise the veteran entitlement system." This is the Interim Report's Number One Priority.

Now is not the time to introduce legislation which entrenches legislative differences and leaves some disabled veterans paying more tax on their invalidity benefits than others. The draft *Treasury Laws Amendment Bill 2022: Taxation of Military Superannuation Benefits* embeds different tax treatment regimes for veterans depending on when they started receiving payments and the scheme. For example:

- Veterans with the same date of enlistment, same employment and pay, same length of service and with the same disability, and receiving the same Invalidity Benefit payment under the same superannuation scheme, can be taxed differently.
- Veterans whose Invalidity Benefits payments commenced on or after 20 September 2007 receive more favourable taxation treatment than those whose payments started prior to that date.
- Except those veterans covered under the newer ADF Cover (2016) are not eligible for the same
  favourable taxation treatment of Invalidity Benefits as their mates serving beside them but on the
  earlier super schemes. Most would be unaware of this. Some may have even chosen to change to the
  new scheme, without being aware of this significant difference.

Can this different treatment really be justified?

The beneficial effects of the proposed legislation for veterans and their surviving dependents should be extended to all veterans receiving Invalidity Benefits for similar disabilities.

DFWA urges the Government take this opportunity to simplify and harmonise the tax treatment of veterans' Invalidity Benefits, and not entrench the differences and difficulties causing adverse effects on veterans' mental health as highlighted by the Royal Commission.

# ALERT BE WARY OF A 'RSL' GUISED PHONE SCAM IN PLAY

#### **ALERT: RSL PHONE SCAM**

We have recently been alerted to a phone scam operating under the guise of RSL. Members of the public have reported receiving calls from individuals claiming to be RSL staff members and seeking 'opt-ins' to the charity.

Please note, RSL Australia does not undertake any telephone marketing and will never ask for financial contributions, donations or for any personal information via this channel.

While some of our RSL Branches do undertake fundraising campaigns periodically, this is typically through street appeals or via official RSL websites.

As per Australia's Cyber Security Centre advice, we encourage people to be extra cautious if asked to supply personal details or financial contributions via an unknown phone number or email. The recommended advice is to decline and seek clarification through the official company contact lines.

#### **DVA Deputy Commissioner update**

Please find below an update on some key activities across DVA, and I encourage you to share these with your colleagues and members.

#### **Royal Commission Interim Report**

The Royal Commission provided its Interim Report to the Governor-General on 11 August 2022. The Interim Report has been tabled in Parliament and is available on the Royal Commission's website

(<u>defenceveteransuicide.royalcommission.gov.au</u>). Hard copies can also be ordered from this website.

The Royal Commission has made 13 recommendations in the report. The Interim Report outlines a number of recommendations in relation to improving compensation claims processes and implementing legislative reform.

The Government has welcomed the Interim Report from the Royal Commission and thanked all those who have contributed to the work of the Royal Commission. The Government has stated it will carefully consider all the recommendations contained in the report and issue a full response in due course.

DVA welcomes the Royal Commission as an opportunity to learn and strengthen our approach to the mental health and welfare of our veterans and families. We acknowledge there is still plenty of work to do to further reform and improve the services and support available to our serving and ex-serving ADF communities. The Interim Report has provided advice on key areas we should focus on.

#### **Prime Minister's National Veterans' Employment Awards**

On 30 August 2022, Minister for Veterans' Affairs Matt Keogh announced the finalists for this year's Prime Minister's National Veterans' Employment Awards.

These awards recognise organisations that actively recruit, employ and support veterans, as well as celebrating individual veteran and partner employees and entrepreneurs who are excelling in the civilian workplace. This year's finalists have gone above and beyond to foster environments where veterans and partners can not only work, but thrive.

The Awards are the flagship of the Prime Minister's National Veterans' Employment Program, which brings together a range of resources and initiatives to support veteran and partner job-seekers and employers. See <u>DVA website</u> for more.

#### **Veterans' Health Week**

#### **Grants**

#### **Grants-in-Aid**

Fifteen ESOs have each secured a share of \$145,000 in funding as the successful recipients of the 2022–23 Grants-In-Aid. The funding will be used by the organisations to provide vital support to the veteran community and improve communications between their networks. Among the 15 recipients is Legacy Australia, which supports the partners and children of veterans that gave their lives or health serving our country, and the Defence Force Welfare Association, which advocates for veterans on welfare matters.

#### **BEST** grant recipients announced

A total of 119 ESOs across Australia will share in \$4.45 million of funding for advocacy and wellbeing services for veterans under the Australian Government's Building Excellence in Support and Training (BEST) grants program.

Recipients of the 2022–23 BEST grants program will receive financial support to continue to assist veterans and families who may need help with claims, accessing health, housing and other community services and/or other benefits. The funding is a contribution towards the wages of compensation advocates and their support staff, as well as equipment and administration expenses they may require as part of delivering services to veterans and families.

The MindRight program specifically targets common major problems veterans experience when leaving the military such as:

- Frustration from a clash between military and civilian codes.

MindRight is a one-day, peer-led course which will equip service men and women with the tools to understand:
